



Then click the 'Make Payment' button and you're done!









After making the payment, you will receive a payment notification, as illustrated here.






This is what the transaction details look like.









This is how the transaction details look like, from the recipient's perspective.












DEXA WALLET & EXTERNAL TRANSACTIONS

You will be able to buy these assets directly from our wallet, through our third- party service provider.



Prepaid Cards




